

Official Rules for Books-A-Million's 'Hometown Screening of The Darkest Minds' Sweepstakes
("Sweepstakes")

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING.

1. Eligibility:

Sweepstakes starts June 17, 2018 at 12am CST and ends on July 21, 2018 at 11:59 pm CST (the "**Promotion Period**"). All entries must be received prior to July 21, 2018 at 11:59pm CST. This Sweepstakes is open only to legal U.S. residents of the fifty (50) United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry who have provided a valid email address and phone number. Only one (1) entry per person will be accepted. Officers, directors and employees of Books-A-Million, Inc. ("**Sponsor**"), Twentieth Century Fox Film Corporation ("**FOX**"), The Walt Disney Company, or their respective affiliated or subsidiary companies, distributors, retailers, sales representatives, advertising and promotion agencies (all such individuals and entities referred to collectively, the "**Promotion Entities**"), and their immediate family members and/or those living in the same household of such persons, are not eligible to enter the Sweepstakes. The Sweepstakes is governed by the laws of the United States. All federal, state, and local laws and regulations apply. Void where prohibited.

2. To Enter:

Enter online at www.booksamillion.com/sweepstakes (the "**Website**") by completing the entry form. Click "Submit Entry" to submit your entry for the Sweepstakes. Upon completion and submission of the entry form, you will receive one (1) entry in the Sweepstakes. Entries must be received by July 21, 2018 at 11:59pm CST, to be eligible. No entries will be accepted beyond this time. Limit one (1) entry per person and/or e-mail address. Incomplete, illegible, or mechanically reproduced entries will be disqualified.

Entry must be made by the entrant, only at the Website. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. Tampering with the entry process or the operation of the Sweepstakes, including but not limited to the use of any device to automate the entry process, is prohibited and any entries deemed by Sponsor, in its sole discretion, to have been submitted in this manner will be void. In the event a dispute regarding the identity of the individual who actually submitted an entry cannot be resolved to Sponsor's satisfaction, the affected entry(ies) will be deemed ineligible. The Promotion Entities shall not be responsible for incorrect or inaccurate entry information whether caused by Internet users or by any of the equipment or programming associated with or utilized in the Sweepstakes or by any technical or human error which may occur in the processing of the entries in the Sweepstakes. The Promotion Entities assume no responsibility or liability for any error, omission, interruption, deletion, theft or destruction, or unauthorized access to, or alteration of entries.

3. Winner Selection:

One (1) winner will be randomly selected by the Sponsor from the pool of eligible entries received during the Promotion Period ("Prize Winner"). The odds of winning depend upon the number of eligible entries received during the Promotion Period. The drawing will be conducted by Sponsor or its designee, using randomization methods selected by Sponsor in its sole discretion.

4. Winner Notification:

The potential Winner will be notified via phone or email within two (2) business days of the selection date. If the prize goes unclaimed, an alternate Winner will be selected. The Winner will have forty-eight (48) hours from the date of notification to claim the prize or an alternate Winner will be selected. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential Winner for any reason. If any potential prize Winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the applicable prize for any reason prior to award, such potential prize Winner will be disqualified and an alternate Winner may be selected. Sponsor may successively attempt to contact up to two (2) potential prize Winners in accordance with such procedure, and if there is still no confirmed Prize Winner after such attempts have been made, if any, the applicable prize may go unawarded.

5. Prize:

One (1) prize is available. The prize package includes:

*A private (hometown) screening of the movie *The Darkest Minds* for fifty (50) attendees in a theatre located in the winner's hometown theatre.

At least 1 person attending must be over 21. The prize excludes meals, and drinks, excursions, attractions, treatments, personal expenses and anything not expressly stated in the prize package; all elements of the prize are subject to availability; if unavailable, experiences and items of a similar nature and value may be offered; once booked, the prize cannot be amended or cancelled; prize is non-refundable and non-transferable; no cash alternative is available; movie screening will take place on a set date in 2018 specified by promoter, in no event earlier than Thursday 8/2/18 at 4PM ET; if the winner is unable to, or elects not to, use part of the prize, the winner will forfeit that part of the prize package. In the event the Prize Winner and/or any of his or her guests engages in behavior that, as determined by Sponsor in its sole discretion, is obnoxious or threatening, illegal or that is intended to annoy, abuse, threaten or harass any other person, Sponsor reserves the right to terminate the prize early, in whole or in part, and send the Prize Winner and/or his or her guests home with no further compensation.

The approximate retail value ("**ARV**") of the prize is \$442. The ARV represents Sponsor's good faith determination of the actual fair market value and, as ultimately determined by Sponsor, is final and binding and cannot be challenged or appealed. In the event that a stated ARV is more than the actual

fair market value, the difference will not be awarded in cash or otherwise. The prize is non-transferable and no substitution or cash equivalents will be made except as provided herein at the Sponsors' sole discretion.

Once each of the Prize Winner's guests is designated, he/she may not be substituted, except at the Sponsor's sole discretion. If the Prize Winner is unable to attend the trip on the date set forth by Sponsor, the prize will be forfeited in its entirety. In the event that the trip does not or cannot take place as scheduled or at all, for reasons included but not limited to scheduling conflicts, cancellations, postponement, an event of "Force Majeure" (defined below), or for any other reason, then in lieu of the trip, the Prize Winner will receive the remaining components, if any, of the prize, which shall constitute full satisfaction of Sponsor's prize obligation to the prize winner, and no other or additional compensation will be awarded.

6. General Conditions:

No cash alternative or substitution of prizes will be allowed, except Sponsor reserves the right in its sole discretion to substitute prizes of comparable value if any prize listed is unavailable, in whole or in part, for any reason. The prize will be awarded only if the potential Prize Winner fully complies with these Official Rules. All portions of the prize are non-assignable and non-transferable. Any prizes pictured in point-of-sale, online, television and print advertising, promotional packaging, and other Sweepstakes materials are for illustrative purposes only. All details and other restrictions of the prize not specified in these Official Rules will be determined by Sponsor in its sole discretion. The Prize Winner shall be solely responsible for all federal, state and/or local taxes, and the reporting consequences thereof, and for any other fees or costs associated with the prize. The potential Prize Winner may be required to execute an Affidavit of Eligibility, a Liability Release, and (where imposing such condition is legal) a Publicity Release (collectively, "**Prize Claim Documents**"). If a winner is a minor, at Sponsor's option, the applicable prize either will be awarded in the name of the parent or legal guardian of such minor winner, or the parent or legal guardian of such minor winner will be required to ratify and sign Prize Claim Documents. If any potential winner (or, in the case of a minor, such minor winner's parent or legal guardian) fails or refuses to sign and return all Prize Claim Documents within ten (10) days of prize notification, or such other time as indicated by Sponsor in its sole discretion, the winner may be disqualified and an alternate winner may be selected.

Sponsor makes no warranties, and hereby disclaims any and all warranties, express or implied, concerning any prize furnished in connection with the Sweepstakes. WITHOUT LIMITING THE GENERALITY OF THE FOREGOING, SUCH PRIZES ARE PROVIDED "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESS OR IMPLIED, AND SPONSOR HEREBY DISCLAIMS ALL SUCH WARRANTIES, INCLUDING BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE AND/OR NON-INFRINGEMENT.

7. General Liability Release/Force Majeure:

Acceptance of a prize constitutes Winner's (or any minor winner's parent or legal guardian) permission for the Promotion Entities to use Winner's name, photograph, likeness, voice, biographical information,

statements and address (city and state) for advertising and/or publicity purposes worldwide and in all forms of media now known or hereafter developed, in perpetuity, without further compensation. Sponsor reserves the right in its sole discretion to disqualify any individual who is found to be tampering with the entry process or the operation of the Sweepstakes or the Website, to be acting in violation of these Official Rules, or to be acting in an unsportsmanlike or disruptive manner, or with the intent to disrupt or undermine the legitimate operation of the Sweepstakes, or to annoy, abuse, threaten or harass any other person, and Sponsor reserves the right to seek damages and other remedies from any such person to the fullest extent permitted by law. No mechanically reproduced, illegible, incomplete, forged, software-generated or other automated multiple entries will be accepted. Sponsor reserves the right to modify, extend, suspend, or terminate the Sweepstakes if it determines, in its sole discretion, that the Sweepstakes is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond Sponsor's control have destroyed or severely undermined or to any degree impaired the integrity, administration, security, proper play and/or feasibility of the Sweepstakes as contemplated herein. If the Sweepstakes is terminated before the designated end date, Sponsor will (if possible) select the winner in a random drawing from all eligible, non-suspect entries received as of the date of the event giving rise to

the termination. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances. Only the type and quantity of prizes described in these Official Rules will be awarded. These Official Rules cannot be modified or amended in any way except in a written document issued in accordance with law by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

7. Conduct:

All Sweepstakes participants agree to be bound by these Official Rules. Sponsor in its sole discretion, reserves the right to disqualify any person it finds to be in violation of these rules.
